Step 4. Sign up for your dogs first day of daycare!

Almost Home dog daycare is available Monday through Friday from 6:30 a.m. to 6:00 p.m. We are also open on Saturday between the hours of 8:00 a.m and 12:00 p.m. Almost Home Boarding is available everyday of the year (including Sundays and holidays). ## Guidelines

Almost Home has set up some guidelines to ensure the safety and health of all daycare and boarding clients. The following guidelines and rules apply.

- All dogs and cats must be 12 weeks of age or older.
- All dogs 6 months or older must be spayed or neutered to be allowed in daycare.
- All dogs must have up-to-date vaccinations. Owners must submit proof of the following vaccinations for dogs: DLHPP (distemper, hepatitis, leptospirosis, parainfluenza, parvovirus), rabies, and bordatella.  
Owners must submit proof of the following vaccinations for cats: rabies, distemper, boardatella.  
Written proof/certificate from Veterinarian required. You or your veterinarian can email, fax, or mail proof of vaccinations prior to your visit.
- Flea and heartworm preventatives are encouraged but not required. This should be discussed with your veterinarian.
- All dogs must be in good health. Owners will certify their dog(s) or cat(s) are in good health and have not been ill with a communicable disease in the last 30 days. Upon admission, all dogs and cats must be free from any condition which could potentially jeopardize the health or safety of other clients. Dogs or cats who have been ill with a communicable disease in the last 30 days will require a veterinarian's certification of health to be admitted or re-admitted. No dogs will be allowed to attend daycare with visible stitches or bandages.
- Daycare only. All dogs must be non-aggressive and not food or toy protective. Owners will certify that their dogs have not harmed nor shown any aggressive or threatening behavior towards any person and/or other dog(s). Please remember your dog(s) will be spending time with other dogs and the safety, health, and enjoyment of all clients is our primary concern.
